Week ending November 8, 2024

Last week, the equity markets experienced significant gains, with the S&P 500 posting its largest weekly gain of the year. This surge was largely driven by positive reactions to the U.S. election results, which were seen as favorable for corporate earnings. The Federal Reserve's decision to cut interest rates by 25 basis points also played a role, although the Fed maintained a cautious stance on inflation. Bond yields saw notable fluctuations, initially spiking mid-week before settling down. Overall, the markets were buoyed by strong economic data and investor sentiment, leading to record highs for the major indices.

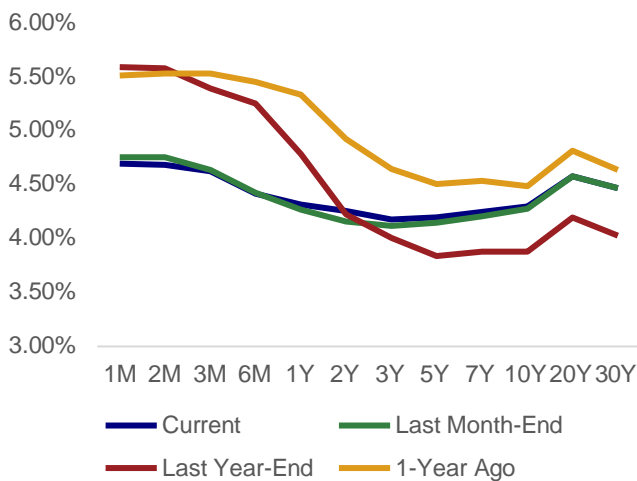
Fixed Income Markets Overview

- Bond yields experienced significant fluctuations, initially spiking mid-week following the election results but eventually settling down by the end of the week. The Federal Reserve cut interest rates by 25 basis points, which was widely anticipated, and this decision influenced bond market movements.
- The yield on the 10-year U.S. Treasury briefly surged to a four-month high before easing back down, reflecting the market's reaction to both the election and the Fed's rate cut.
- Expectations for future Fed rate cuts have been adjusted, with the market now pricing in fewer cuts over the next year compared to previous forecasts.

Equity Markets Overview

- All three major indices experienced had strong rallies last week after election results came in. They all broke new highs during the week and posted their largest weekly gain in the past 12 months led by the Nasdaq's 5.8% gain.
- Every sector ended the week with a positive return last week. Consumer Discretionary led the pack with a 7.6% weekly gain and Utilities brought up the rear with a 1.2% rise.
- From a size perspective, small-cap stocks' 8.6% rally bested their large- and mid-cap peers' gains of 4.7% and 6.3% respectively. From a style perspective, growth stocks bested their value counterparts across all market caps, though outperformance in the small- and mid-cap segments was almost negligible.

Alternative Markets Overview

- U.S. crude oil prices rose about 1% last week following the election results.
- Gold prices experienced their sharpest weekly decline in over five months, influenced by a stronger dollar and the market's reaction to Donald Trump's victory.
- Bitcoin outperformed all other asset classes last week with a 10.9% gain. The cryptocurrency has experienced a strong rally since the election results came in and has since proceeded to set several new all-time highs.

S&P Smallcap 600 Index measures the performance of 600 small-sized U.S. companies to reflect the small-cap segment of the U.S. equity market, which is typically known for less liquidity than large cap stocks.

MSCI ACWI ex-US Index captures large and mid-cap representation across 22 of 23 Developed Markets (DM) countries (excluding the US) and 24 Emerging Markets (EM) countries.

MSCI Emerging Markets Index captures large and mid-cap representation across 24 Emerging Markets (EM) countries.

Bloomberg Barclays Global Aggregate Bond Index provides a broad-based measure of the global investment-grade fixed income markets, with three major components of this index are the U.S. Aggregate, the Pan-European Aggregate, and the Asian-Pacific Aggregate Indices.

Bloomberg Barclays U.S. Aggregate Bond Index represents securities that are SEC-registered, taxable, and dollar denominated. The index covers the U.S. investment grade fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities.

Bloomberg Barclays U.S. Treasury Aggregate Bond Index is the U.S. Treasury component of the U.S. Government index and represents public obligations of the U.S. Treasury with a remaining maturity of one year or more.

Bloomberg US TIPS Index consists of Inflation-Protection securities issued by the U.S. Treasury.

Bloomberg Barclays US Corporate Bond Index is the Corporate component of the U.S. Credit index and represents publicly issued U.S. corporate and specified foreign debentures and secured notes that meet the specified maturity, liquidity, and quality requirements.

Bloomberg Barclays U.S. Corporate High Yield Index covers the universe of fixed rate, non-investment grade debt.

Bloomberg Barclays Emerging Markets Bond Index is broad-based with country eligibility and classification as an Emerging Market being rules-based and reviewed on an annual basis using World Bank income group and International Monetary Fund (IMF) country classifications.

Bloomberg Barclays U.S. Municipal Index is a rules-based, market-value-weighted index engineered for the long-term tax-exempt bond market.

Bloomberg Barclays US High Yield Municipal Index is an unmanaged index of noninvestment-grade municipal debt securities, which provides a representation of the performance of US high-yield tax-exempt bonds.

Federal Funds Rate is the interest rate at which depository institutions trade federal funds (balances held at Federal Reserve Banks) with each other overnight.
